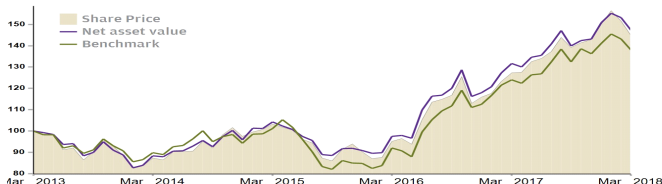

Management Commentary

Stock selection in Brazil hurt performance, as the largest apparel retailer, Lojas Renner, fell following weaker-than-expected fourth-quarter results. Stock selection in the financial services sector was mixed but positive overall. The overweight in Housing Development Finance Corporation (HDFC) hurt performance as the fraud scandal at Punjab National Bank weighed on the overall sector. Meanwhile, Sberbank, Russia's largest lender, and Capitec, a high quality bank in South Africa, added value. Overweight exposure to Argentina - a result of our position in leading ecommerce company MercadoLibre - added value. The share price was buoyed by strong topline results. The fund uses our comprehensive research platform to identify high-quality businesses that compound earnings sustainably over long periods, resulting in a long-term, high-conviction portfolio with a quality and growth bias.

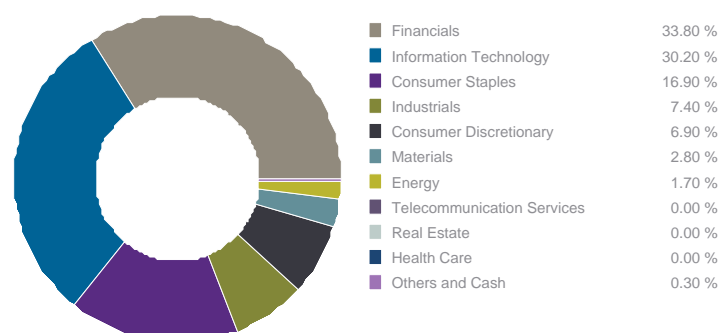

GLOSSARY OF TERMS

BENCHMARK COMPARISON - Comparison of the Company's performance is made with the benchmark. The benchmark is a recognised index of stocks which should not be taken as wholly representative of the Company's investment universe. The Company's investment strategy does not follow or track this index and therefore there may be a degree of divergence between its performance and that of the Company.

CASH - Net current assets including investment in liquidity funds & treasury stocks (if held) and drawn revolving credit facilities (if any) with an original maturity of less than 1 year.

DISCOUNT / PREMIUM - If the share price of an investment company is lower than the net asset value (NAV) per share, the company is said to be trading at a discount. If the share price of an investment company is higher than the net asset value (NAV) per share, the company is said to be trading at a premium. The discount/premium is shown as a percentage of the NAV.

GEARING - Gearing represents the excess amount above shareholders' funds of total assets expressed as a percentage of the shareholders' funds. Total assets include total investments and net current assets/liabilities less cash/cash equivalents and excluding bank loans of less than one year. If the amount calculated is negative this is known as a 'net cash' position.

SECTOR / GEOGRAPHICAL BREAKDOWNS - These are expressed as a percentage of total portfolio and cash. Investments in liquidity funds will be shown as cash.

TOP 10 HOLDINGS - These are expressed as a percentage of total portfolio and cash. Investments in liquidity funds / treasury stocks will not be shown in the top 10 holdings.
