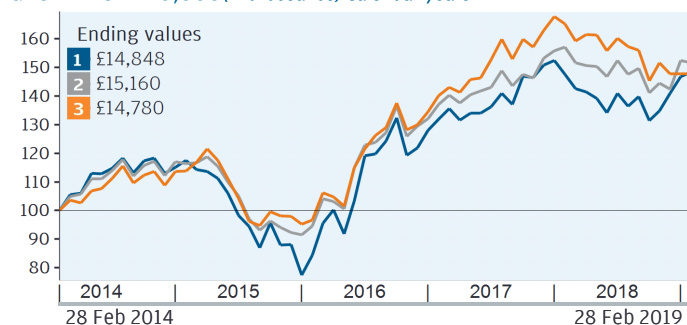

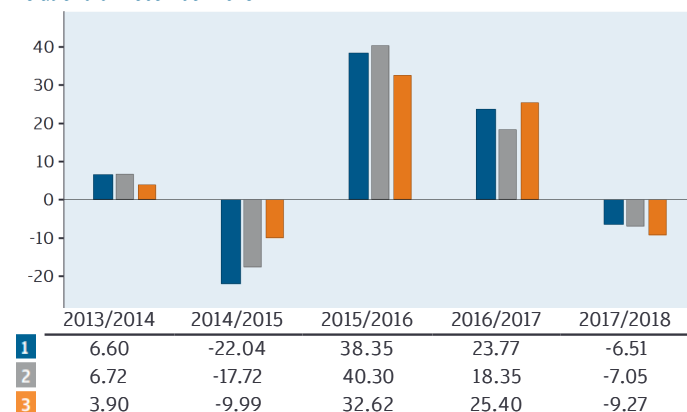

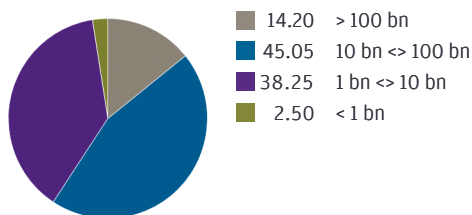

DEFINITIONS

shown as a percentage of the NAV.
